# FCA National Conference: Sept. 2020

In the late 1990s, I had the privilege of serving as a board member and as President of our national organization, Funeral Consumers Alliance (FCA) and participated in several Biennial Conferences. This year the Conference was moved to a virtual platform. I found the meeting rewarding and fresh, as did other affiliate board members. All the sessions were recorded and are available free on the FCA website:

The selections are broad, and you should be able to find one or more of interest. The featured Keynote Speaker, Dr. Kami Fletcher, Associate Professor of History, Albright College, presented on "African - American Undertaking: History, Burial Rights and Deathwork."

Josh Slocum, Executive Director, opened the Conference with an update on FCA's involvement with other consumer groups urging the FTC to make changes to the "Funeral Rule" (originally adopted in 1984) which would, among other things, mandate online price disclosure by funeral homes. I believe you will find this worthwhile and even entertaining.

### The Ohio Board of Embalmers and Funeral Directors

OBEFD is the state body that inspects, licenses, writes rules following legislation, and handles complaints regarding cremation facilities and funeral homes. It has the authority to levy fines and close facilities. I attend this group's monthly board meetings as a private citizen.

I have been following two issues: The Preneed Recovery Fund helps families recoup funds if a funeral home misuses preneed funds. Funeral homes pay \$10 for each preneed contract they sell. As of September 16, 2020, the Board had \$823,000 in this fund, and \$30,000 was expended for seven claims.

The second issue is the Ohio Indigent Burial and Cremation Support Program created by the Legislature, effective in late 2019. Only municipalities may be reimbursed for burial or cremation costs of indigent persons. As of August 31, 2020 (FY 2021), three applications were paid out for a total of \$2,335. For FY 2020, 85 payments totaled \$60,778.47.

The Board has identified concerns about funeral homes that are closing. Where are their preneed contracts going? Are there any cremains left in the funeral home?

COVID-19 and Death Care (By Cathy Elkins)

The Ohio Board of Embalmers and Funeral Directors has sent their members directions on handling deceased persons in this day of COVID-19. (For details: www.funeral.ohio.gov)

Our two contracted providers were contacted for their input. Cook & Son-Pallay (Columbus) said the funeral home has not seen much impact, with only one or two cases. All staff and visitors must wear masks, and hand sanitizer is available. They have not needed to limit the number of visitors for viewings. Viewing before cremation requires embalming, which is done by an outside vendor, so PPE is not an issue. They do not have the ability to live-stream a funeral service, but Wi Fi is available in the parlor so the family can do it.

Conroy Funeral Home in Springfield reports only about 2 to 3 cases of COVID-19 so far. Some PPE is hard to get. Visitation is limited to one hour, only on the day of funeral. Attendance is limited to thirty persons. Masks are required for staff and visitors, and hand sanitation stations are available. They are able to livestream funerals through YouTube.

Cemeteries have different rules about the number of persons allowed for a burial.

### Celia Elkins

- In 1960, the percentage of Americans choosing cremation was just 4%. In 2019, the percentage of Americans choosing cremation was 54.6%.
- A cremation permanently destroys all traces of DNA.
- Your disposal options are numerous. The cremains can be interred in a cemetery plot, retained by a family member, scattered on your private property, or at a place that was significant to the deceased.
- <u>Always</u> check local regulations regarding scattering in a public place. Scattering ashes is generally forbidden in public parks. Your funeral director can help you with this .
