Many of you will remember Rev. Gupton from his time at the Columbus First Unitarian Universalist Church. He lives in Cincinnati with his wife, Jennifer Sanders, and is the minister of the Heritage Unitarian Universalist Church in Cincinnati. Rev. Gupton, a member of the Cincinnati Funeral Consumers Alliance, has studied, preached about and promoted green burial. He has led Death Cafes and has been active in the Death Positive movement for many years.

Having just finished the book, 'Grave Matters: a journey through the modern funeral industry to natu-

ral way of burial' by Mark Harris, I am definitely looking forward to what Rev. Gupton has to say on this topic. Harris took me on a detailed tour of all the possible options and what they entailed physically and financially for the deceased person as well as the survivors. Until I read this book, I honestly had a 'who cares' attitude about body disposal, except for saying no one was going to look at my dead body and that I preferred cremation. Now, I realize this is a decision that requires some real thought. It isn't just time, money and space. There is the environment to consider and maybe cremation isn't the quick easy answer. I am looking forward to Rev. Gupton adding to our knowledge about the options.

In Central Ohio Ann Harr (annmharr@gmail.com), a former board member of FCACO, has worked with many families on arranging home funerals. She stressed the importance of preplanning and communication between family members. It is important to designate a person who can become educated about the process. This person will have to work with the local health department. Identifying an ally is invaluable. Many of the documents will originate there and will need to be returned there. These offices are closed on weekends and holidays. There are many ways to have a home funeral. The family can do everything, or can engage a funeral home to help with some aspects.

Ann mentioned a poignant home funeral she was involved with. All was planned ahead of time. The family had their mother reclining on a chaise lounge in her bedroom. She was made up beautifully and was wearing one of her lovely gowns. This room was just off of a sun porch where visitors could circulate, visit the deceased and each other, and share refreshments. It was a natural and beautiful ending to a life well lived.

Columbus Public Health Department of Vital Statistics has a "No Funeral Home Packet" that will take a person through the process. This can be obtained by calling (614) 645-7417.

## Featured Speaker: Reverend Bill Gupton

**Synopsis of Topic:** The National Home Funeral Alliance provides support, information and resources for families and friends who seek to care for a deceased loved one themselves, thus bypassing the funeral home and the American funeral industry. The NHFA is part of a growing movement to reclaim traditional death practices such as dying at home, caring for the body at home, visitations and memorial services in the home, and natural or "green" burial. Its mission includes advocacy for the rights of the dying and their loved ones, and education (most Americans, for example, do not know that it is

PERFECTLY LEGAL to take care of and prepare a loved one's body for burial or cremation). A "home fu" was the only type of memorial for the dead prior to the "professionalizing" of death services in recent generations. Today, such home- and community-based rituals are more meaningful and moving, help with healthy grieving, and are both far less expensive and far less harmful to the environment than current funeral practices. ## Funeral or Cremation Jewelry by Marylou MacDonald

Imagine a pinch of cremains for a keepsake in one of hundreds of designs of rings, bracelets, earrings, pendants, photo engraved items, key chains, even pet mementoes. Items may be made of stainless steel, titanium, glass, wood, precious metals of gold and silver and, all, consumers are told, are to symbolize continuing love, to enable one to cope more easily, to hold in hand a source of comfort and to find peace in the heart.

Popular in England during the Victorian Era and in the United States during the Civil War, a resurgence of the centuries-old "mourning" jewelry came about in 1992. Hair was the first keepsake as cremation was rarely done. Hair art, an ancient practice, creates wreaths, earrings, necklaces, bracelets, bonnets and other decorative

accessories entirely from human hair. The pieces resemble intricate crochet work.

Cremation jewelry contains a concealed urn which allows for a tiny amount of ashes. The economically minded, do-it-yourselfers, can order a “standard” piece (starting at \$29.95) which includes a kit of instructions, a funnel and adhesive with which to fill and seal the urn. Custom pieces are made by adding ashes to glass beads and pendants. Top-of-the-line products could be diamonds and crystals made out of ashes. If there is psychological discomfort in wearing any personal remains, photo engraved jewelry provides an option.

Consumers may find jewelry for sale at funeral homes or troll the many websites for price comparisons. As always, FCACO suggests shopping at one’s own risk.
