It has been just over a year now since our financial markets went into a freefall. Slowly things seem to be returning to some sort of normalcy. One effect of FCACO President the past year is that people are looking

more closely at their spending patterns, and I would suspect that includes funerals/cremations. We get many phone calls asking if we provide funds for people who don't have the cash or credit to pay for a loved one's funeral or cremation. True, people should plan ahead for this certain eventuality and put money aside perhaps either in a savings account or as an insurance policy. But some don't or can't and some die earlier than would be expected. We do not provide funds but can help the caller by

using our survey to direct them to the lower priced options. These are difficult phone calls to take and answer. There is, of course, a legal responsibility from all municipalities to take care of indigent persons, but many times these callers are not eligible even though poor.

This brings me to the thought that we who are members of FCACO are fortunate, indeed, that we have put our plans in order...and if we have not yet done so, still have that opportunity. This planning ahead is especially important to our survivors. Make sure you have written everything down for them so that all is known. Talk to them. Make sure they know your wishes. The end of the year is a wonderful time to do this "housekeeping." If you haven't already obtained the BIG pack ("Be-

I have been volunteering for FCACO for many years and find our organization more important than ever! People who have never purchased a funeral oftentimes do not know or understand what's involved and what their rights are. Costs are increasing. Becoming a member and attending informational meetings along with our newsletter provides valuable information. While I'm talking about our organization, formerly known as the Memorial Society, I'd like you to realize there is a commercial funeral establishment in Columbus which named itself the Columbus Cremation and Memorial Society. They use a Web site which has a ".org" ending, which most people think is a non-profit. They are not. Please be sure that when you talk with friends about joining with us they actually contact us, the non-profit funeral information organization serving the Columbus area since 1953 and conforming with the description of a memorial society by the Federal Trade Commission.

News From Our National Organization

Josh Slocum, Executive Director of FCA, reports that he recently testified before Congress on behalf of FCA and all funeral



consumers concerning the need to bring cemeteries, crematories, monument dealers and caskets retailers under the Federal Trade Commission's Funeral Rule. (Read about the Bereaved Consumer's Protection Act at http://www.funerals.org/become*member*). The significance of the Funeral Rule, established in 1984, is to protect consumers purchasing funerals. This set of rules says, among many other things, that a printed price list must be provided to a consumer. You can read a full version of the Funeral Rule at this address: http://www.ftc.

Many affiliates worked for years to bring the Funeral Rule to fruition and we will be pleased to see this additional consumer protection established. We have prepared a document which is posted on our Web site, *www.funeralsohio.org.* If you cannot access the Web site, phone the office and we will send it to you. Among the topics: Decision Making (who has the right); Information needed for an Ohio Death Certificate; Other Decisions; After Disposition. This is a work in progress and will be amended as new information is obtained. Be sure to check the Web site regularly.
