Putting Your Donations to Work

FCACO is run entirely by volunteers who help people facing difficult circumstances. Your tax-deductible donations make it possible to maintain a website, a dedicated telephone line, and an email account. We serve both members and non-members. One call came from a woman in Cincinnati whose mother was a member of the Cincinnati FCA, which no longer exists. The death was well-handled by the contracted funeral home. She was directed to our FCACO website to look at our survey of prices for funeral homes in Central Ohio and then talk to the funeral home that handled her mother's funeral. to discuss a prepayment option, selecting only those services that she would like.

A more complicated inquiry originated from a man who was at the hospital where his mother had just died. The family was from a South American country so American funeral practices were difficult for him to understand. I referred him to our website to compare area funeral costs. I recommended that he speak with his mother's parish priest for more options.

An interesting call came from a woman with serious concerns about the placement of a headstone. I advised her how to contact the cemetery owner. Cemeteries in Ohio are regulated by the Division of Real Estate, not by the Board of Embalmers and Funeral Directors which handles only funeral disputes.

Being Mortal,- Medicine and What Matters in the End by Atul Gawande (Review by Joan Matyskella)

We will have a book club discussion in December. The book is "Being Mortal", by Dr. Atul Gawande, the son of immigrant parents from India, a surgeon who grew up in Athens, Ohio. Released in 2014, it was praised for its masterful exploration of aging, care at the end of life, and the medical profession's need to deal with the wishes people might have beyond mere survival. It quickly became a NY Times bestseller. I read it then and bought a paperback copy. It is a book that can help all of us "mortals" to gain more understanding of the end stages of life, the trauma of sudden illness, and to deal with the troubling uncertainty of "how to proceed" when hard choices have to be made. News from the Ohio Board of Embalmers and Funeral Director

The Ohio Board of Embalmers and Funeral Directors (OBEFD) is taking strong action against funeral directors who misuse funds from prepaid funeral contracts. Currently, the Board is investigating a Columbus funeral home that was sold to another Columbus funeral home. The receiving funeral home has no record of several preneed (paid in advance) files. The Board has reimbursed one family for its financial loss from the Preneed Recovery Fund. The others are still under investigation. The Franklin County Prosecutor may get involved. This Board is intent on making funeral homes follow the law. Since establishing the Preneed Recovery Fund in 2017 until July 31, 2024, 32 applications have been approved.

The last two Ohio fiscal budgets have failed to fund the Indigent Burial Fund. A bill to restore the funding has passed the Ohio House and is now in the Ohio Senate.

Finally, OBEFD anticipates that the Federal Trade Commission will revise The Funeral Rule to require that all funeral homes with websites list their prices online. As of late October, the FTC has not acted.


