Eye-Opening Insights from the FCA Conference

I recently attended the Funeral Consumers Alliance 2025 Biennial Conference, and the revelations from the presentation on "Confronting Funeral Poverty in Our Communities" were truly striking.

The Shocking Reality

Did you know that funerals rank as the third largest expense most families will face—after buying a home and a car? This staggering cost has led to a heartbreaking trend: families abandoning remains they simply cannot afford to bury.

Voices That Made an Impact

Pamela Prickett, co-author of *The Unclaimed: Abandonment and Hope in* the City of Angels, delivered a powerful keynote speech on this crisis. Meanwhile, Miranda Panther shared moving Native American burial customs, including the sacred tradition of hand-digging graves as a final gift to the deceased.

We also heard from **Nasser Khadjenorri** about the world's largest cemetery in Iraq (check his fascinating videos at nasserk.com) and Isabel Knight from the National Home Funeral Alliance, who demonstrated how ice and a minivan can make home funerals surprisingly affordable.

Key Takeaways for You

- **Never pre-pay for funeral services**—pre-plan, yes, but don't pay in advance
- Skip final expense insurance
- Consider joining a cemetery board in your community
- Explore alternative options like casket-making clubs
- Professor Victoria Haneman from the University of Georgia was emphatic: "No one should pre-pay." Her research on funeral poverty is available on her website and worth reading.



Recently, I received a call on our FCACO phone from a 92-year-old woman who is the caregiver for her 63-year-old son. He has a new kidney, but is diabetic; he also fell and fractured his femur, and has had quadruple bypass surgery. Because other family members are limited in their ability to assist, most of his care rests with his mother. Various community resources have provided intermittent help; in addition, we sent a resource guide from The Central Ohio Area Agency on Aging, with paperclips on relevant pages. Although the caller has already planned her funeral arrangements, her son has not. In response to his need, the FCACO president and membership chair agreed to provide him a courtesy membership.

What Is a Death Doula?

You've probably heard of birth doulas, non-medical professionals who provide emotional, physical, and educational support to women before, during, and after the birthing process. But what is a *death* doula? A death doula has the same kind of presence, just at the other bookend of life. We walk with people who are nearing the end of their journey, and with the loved ones who stand beside them.

A death doula isn't a medical professional. We don't replace doctors, nurses, or hospice teams. Instead, we offer emotional, spiritual, and practical support. That might look like sitting quietly with someone who's scared, helping a family navigate tough conversations, creating rituals for saying goodbye, or simply making sure the dying person feels seen and heard in their final days. Sometimes it's as simple as making tea and providing a compassionate non-judgmental presence.

End-of-life planning can be overwhelming. There are logistics to manage, feelings to untangle, and a deep, human need for connection. A doula's role is to ease that weight. We normalize the process, help people plan ahead, and provide comfort so that death feels less like a medical event and more like what it truly is: a profoundly natural transition.

In short, a death doula helps people die with dignity, families grieve with support, and everyone involved find a little more peace in the process.

News from the Ohio Board of Embalmers and Funeral Directors

By Ohio law, the Board of Embalmers and Funeral Directors collects a small fee from funeral homes when they sell pre-need contracts. These funds are used to reimburse families that can provide proof their loved one had paid but are refused services because of lost paperwork or other misuse of funds. The Board has recently had to reimburse funds to several families because one local funeral home was purchased by another and did not include the prepaid funeral contracts as part of the transaction as required. When funeral homes do not honor their commitments, this reimbursement to families is an important service provided by the Board.

Another service funded through Ohio law is reimbursement to municipalities for the burial or cremation of their indigent dead. Although the Ohio Legislature used to reimburse up to a million dollars a year throughout the state, the demand for funds did not reach that level. The current amount is \$250,000 a year, with most of this money going to small cities and villages that do not have designated resources of their own. Since this new funding is so low, the Board decided, after much discussion, that they will provide funds on a first-come, first-served basis.
